# A Brief History of the ODNRA

The Oregon Dunes National Recreation Area recently celebrated another anniversary. On March 23rd, 1972, the ODNRA was established by Congress. But there's more to the story than you might first think. As early as 1959, Senator Richard Neuberger attempted to make the dunes, along with the nearby Sea Lion Caves part of the National Park System, but this effort failed. Neuberger tried again to protect the Oregon dunes, this time through a bill that would protect coastlines



across the country, including places as varied as Cape Cod, parts of the Great Lakes, and of course the dunes. This bill also failed to pass Congress. Senator Neuberger passed away in 1960, and it wasn't until more than a decade later, in 1972 that the Oregon Dunes National Recreation Area was established, thanks to legislation introduced by Representative John Dellenback.

# Working Group Updates

<u>Communications & Outreach</u> - Our working group met in early April to plan our spring outreach strategies. We will soon be getting a second printing of *Restoring Oregon's Dunes* and our brochures. **<u>Volunteering</u>** - We had great weather on March 30th for our work party at the Waxmyrtle campground, and were able to remove the Scotch broom around the camp sites. This was our first time using our newly purchased weed wrenches and other tools, thanks to a donation from the Childs-Whitney Trust.

The ODRC is also hosting or participating in multiple Earth Day events this year. On Saturday, April 20th, we're holding a volunteer work party at John Dellenback Dunes, 10:00 AM - 1:00 PM. We'll be joined by the University of Oregon's RARE program. Join us so we can get a huge amount of Scotch broom removed!

The following week, on Saturday the 27th, we're co-hosting a work party with Oregon State Parks. Join us at the Dunes Day Use Area at Honeyman State Park to pull Scotch broom, 9:00 AM - 12:00 PM.

<u>Education</u> - Don't feel like getting your hands dirty on Earth Day? We will also have our educational booth set up on the boardwalk in Florence on Saturday the 20th, from 10:00 AM until 2:00 PM. Displays from many area environmental organizations will be set up near the Farmer's Market.

We also hosted a Science Pub Talk at 7 Devils Brewing Co. this past Sunday. We had a great turnout, and they purchased 10 of our coffee table books for the brewery! Stop in and check them out next time you are in Coos Bay.

**Monitoring** - The monitoring group has been in contact with our other working groups to further refine what types of monitoring efforts are needed, and what kind of information we will be collecting. We will now work on drafting questions or producing a survey to find out what the public already knows about the dunes and how they are getting their information.

**Funding** - We have submitted the application to have another year of the RARE program help staff the ODRC. To fund that position, and several other projects, we have submitted grants to the Collins Foundation and the Ford Family Foundation. Both foundations fund capacity building efforts for new organizations such as the ODRC.

<u>Cooperative Weed Management Area (CWMA)</u> - USFS Botanist Armand Rebischke, who leads the CWMA group and acts as a technical advisor on many restoration projects, will be giving a presentation on invasive weeds of the dunes. Join him on <u>Thursday, May 2nd, at 4:00 PM</u> at the Florence Public Library to learn more about the invasive plants threatening the Oregon Dunes.

#### **Volunteer of the Month**



April's Volunteer of the Month has quite the background story! Dafydd Balston was born in Wales, and had spent many years volunteering to protect the Welsh sand dunes. Broom and gorse are native there, but are being threatened by invasive Rhododendron. Exactly the opposite of the invasive plant dynamic in Oregon's dunes. Dafydd now happily removes plenty of broom at our volunteer work parties, and he organized everything for our outreach at Florence's Earth Day event.
