

Working Group Updates

<u>Communications</u>, <u>Education & Outreach</u> - We met with Douglas County Commissioner Tom Kress to inform him about the ODRC and our projects, and look forward to doing more education and public outreach in Douglas County. We also gave a public educational talk at the Coos History Museum as part of their "Tuesday Talks" lecture series. We had a great turnout and many new folks interested in helping with our volunteer efforts.

The Douglas County Board of Commissioners is holding a Town Hall Meeting regarding OHV Operations on County Roads on Monday, June 17th, at the MAC center in Winchester Bay. 5:30 p.m.

<u>Volunteering</u> - May was a busy month for our work parties. We wanted to try something new, so held work parties during the week, and had a great turnout! Work parties for the public were held on the 8th and 20th at Heceta Dunes. We also worked with a class from North Bend High School and with middle school students from Mapleton. Thanks to all of our volunteers, young and old!

Our next work parties will be held on June 8, 15, and 26. More information about upcoming volunteer events can be found on our website.

<u>Monitoring</u> - The monitoring group has drafted our first protocols to capture before and after photos from volunteer work parties. Throughout this spring and summer, we will begin to document each site before and after removing Scotch broom and other invasive plants. <u>Funding</u> - We have submitted our final proposal to the Collins Foundation to allow us to hire a second year RARE intern, and are now awaiting their decision. Cross your fingers for us!

<u>Cooperative Weed Management Area (CWMA)</u> - The CWMA advisor has been instrumental in helping develop our monitoring protocols, as described above. The CWMA has also applied for \$46,000 in Stewardship Funds for work in 2020.

Volunteer of the Month - Jim Grano

May was particularly busy for ODRC volunteer Jim Grano. You may recognize Jim's name from many of our educational updates, as he has been instrumental in



developing curriculum, leading field trips, and teaching local students about watersheds and the dunes. Did you Know? - Pink and Yellow Sand-Verbena

If you've been in the dunes lately, you've probably been noticing a number of flowering plants. Two species of native sand-verbena can be found in the Oregon Dunes: Yellow sand-verbena (*Abronia latifolia*) is more common, but Pink sand-verbena (*Abronia umbelleta*) can also be found at this time of year. Both varieties have a sweet smelling flower, but are also at risk due to habitat loss from European beachgrass. Thanks to Dina Pavlis for the photos!
