Working Group Updates

Communications, Outreach, & Education-

Congressman Peter DeFazio's support of the Oregon dunes stretches back to work done on naming the John Dellenback dunes trail, so it was no surprise that he is fully supportive of the ODRC's work. While in Oregon on congressional recess in August, the congressman was a presenter at the Coastal Caucus meeting in Florence. This gave the ODRC outreach team the opportunity to discuss dunes restoration and pick his brain on how best to secure long-term funding for restoration efforts. Accompanied by two aides, the congressman was reintroduced to the dunes via a sand rail from Sand Dunes Frontier.



Thanks to owner Chuck Chapman for donating the sand rail ride, which was a first for Mr. DeFazio. He shared stories of riding the dunes in a VW bug he and his brother bought and modified for the sand, but he'd never experienced the thrill of a sand rail ride and he came away impressed. The ODRC looks forward to working with Congressman DeFazio and his staff to draft appropriations language and seek funding opportunities. Additional thanks go to retired Forest Service staff Jeff Uebel and Garret Craig, Central Coast deputy district ranger.

FUNDRAISING OPPORTUNITY

In 2018-19, Eugene's Hult Center for the Performing Arts hosted a three-part National Geographic series and invited non-profits to table at each presentation. Discounted tickets were made available to these non-profits to encourage attendance. In 2019-20, the series is back and the ODRC will again table at the presentations. What's new this year is that the ODRC will have the opportunity to earn \$5 for each ticket we facilitate selling. We will receive a code that ticket buyers will use, so watch for more information about this code and when tickets go on sale. Volunteering- The last two volunteer work parties were well attended with 13 ODRC volunteers on September 14th and 17 volunteers on October 5th. At both work parties, large mature Scotch broom plants were removed, some on pretty steep ground. At September's work party, we finished removing broom from the fuel break behind the houses on Joshua Lane. At the October work party, Sand Dunes Frontier took us out to Tree Island #3 in the big sand buggy where we started working on the south slope of the tree island.

After the September work party, volunteers enjoyed a picnic lunch. Chef Armand grilled bratwurst for everyone, and folks brought a lot of good food to share.

Many thanks to everyone who attended the 29 different work parties held this fiscal year (October 1 to September 30). These work parties do make a difference. Over the last five years, over 50 acres of Scotch broom and gorse have been removed from Heceta Dunes!!! Some areas have been treated multiple times.

The next work party is Saturday, October 12th at Sandtracks Picnic Area on Horsfall Road, north of North Bend, OR from 10AM to Noon. Day use fees are not required for people volunteering.

On Saturday, October 26th from 10AM to Noon, we will be working at Heceta Dunes at the east end of Joshua Lane, Florence, OR.

<u>Funding</u> The ODRC is currently in the process of researching and submitting grants by their specific deadlines to fund the upcoming strategic planning process. Two grants that we are excited to apply for are from The Ford Family Foundation and the Oregon Coast Visitors Association (OCVA) Strategic Investment Fund.

Cooperative Weed Management Area (CWMA)- ODCWMA continues to support dunes weed treatments via gorse control contract, volunteer weed-pull participation, and monitoring efforts. A draft long-term Dunes restoration implementation plan has been created that outlines priorities, anticipated cost and timelines. Note: there will be a short ODCWMA meeting after the ODRC meeting. Agenda: regroup and ID next steps.

Monitoring- For some of the work parties, photo points are recorded with GPS, and before and after photos are taken. These sites can be monitored over time to see how the land and vegetation responds to the Scotch broom removal. Below are photos of before and after at our September 14th work party.
